

For and on behalf of the Jammu and Kashmir State Forest Corporation, it is hereby notified for the information of Public in general and the timber traders/extraction contractors in particular that the auction of the **Fire-Wood to the tune of 1500 Qtls(approx)lying At Haria Chak Nursery @ Rs. 234/Qtls (Rs. Two Hundred Thirty Four Only) inclusive of all taxes aggregating to an amount of Rs.3,51,000.00** on the basis of "As it is, where it is" shall be held through open auction on **19.09.2016 at 11.00 A.M** in the office of the General Manager(West), J&K, State Forest Corporation, Bikram Chowk, Jammu.

The auction through open bids will be conducted in accordance with the following terms and conditions:

1. The intending bidders are requested to inspect the site to be Auctioned prior to their participation so as to have a correct assessment regarding Quality/quantity of the material.
2. The prospective bidders shall have to deposit earnest money to the tune of Rs. 7000.00(Rs. Seven Thousand Only)in the shape of CDR, well before the auction date, pledged to the Divisional Manager (Extraction), J&K State Forest Corporation Jammu, which shall be treated as Security Deposit in respect of the successful bidder. The successful highest bidder shall have to deposit 25% of the bid amount in cash on spot, over and above the earnest money and the balance amount within seven days after issuance of sanction.
3. In case there will be increase in quantity after proper weighment at the time of disposal, the excess amount on this account shall be recovered from the successful bidder, if decreased the amount deposited on this account shall be re-funded proportionally.
4. No person shall be allowed to participate in the auction unless he deposits the required Earnest Money in shape of CDR.
5. The bids should be quoted in open in presence of all the bidders.
6. No telephonic/telegraphic/postal bid shall be entertained /accepted.
7. The successful bidder shall have to deposit the balance amount of sale value Within seven days.
8. The security deposit of the successful bidder shall be released after the successful completion of work within the prescribed time schedule.
9. The successful bidder is required to remove the purchased stocks in a way as not to create inconvenience/obstruction to the traffic or electric and communication lines and in case of otherwise a suitable penalty shall be imposed for such inconvenience caused.
10. The successful bidder is required to immediately remove the purchased stocks from the site and shall not be kept stacked on the road which can create inconvenience to traffic.



11. The successful bidder shall have to obtain Form-25 from the Forest Department (Territorial Wing), as required under L.T.Rules and it shall be his responsibility.
12. Once the offer of the highest bidder is accepted and the acceptance is Communicated in shape of sanction, it shall assume the character of final deal of the contract and it will be obligatory on the part of the successful bidder to fulfill the contractual obligations.
13. The State Forest Corporation shall not be responsible for any damage due to detention/haulage of the trucks for whatsoever reasons or for violation of L.T.Rules.
14. Only PAN Card Holders will participate in the auction process.
15. The J&K State Forest Corporation reserves the right to accept or reject any bid without assigning any reasons or notice.
16. Any other information that may be required by the bidder can be had from the office of the General Manager (West), J&K State Forest corporation Jammu on any working day during the office hours.
17. Any other condition(s), if found necessary, the same shall be announced separately before opening of the bids.
18. In case of any dispute between the State Forest Corporation and the purchaser/successful bidder in respect of any sale covered under this Auction Notice, the decision of the Managing Director, J&K State Forest Corporation shall be final and binding on both the parties.
19. In case the auction date is declared a holiday or any untoward situation arises due to any eventuality/circumstances, the auction will be held on the following working day at the same venue and time.
