AUCTION NOTICE.

For and on behalf of the Jammu and Kashmir State Forest Corporation, it is hereby notified for the information of Public in general and the timber traders/extraction contractors in particular that the auction of the Marked Trees of Eucalyptus, Shisham Bamboo and other Broad Leaved trees in standing form (in-situ) on the basis of "As it is, where it is" The detail of which is shown in Annexure "A" shall be held through open auction on 8th of February 2017 at 12.00 Noon in the office of the General Manager(West), J&K, State Forest Corporation, Bikram Chowk, Jammu.

The auction through open bids will be conducted in accordance with the following terms and conditions:


1. The intending bidders are requested to inspect the site of plantation marked, to be Auctioned prior to their participation so as to have a correct assessment regarding Quality/quantity of trees and working conditions.
2. The prospective bidders shall have to deposit earnest money in each case equal to the amount as shown in Annexure "A" in the shape of CDR, well before the auction date, pledged to the Divisional Manager (Extraction), J&K State Forest Corporation Jammu, which shall be treated as Security Deposit in respect of the successful bidder. The successful highest bidder shall have to deposit 25% of the bid amount in cash on spot, over and above the earnest money and the balance amount within seven days after issuance of sanction.
3. The prospective bidder shall have required machinery and skilled labour i.e High lift Hydra JCB, chain saw wood cutter, cable wire (electricity) operational equipment and high skilled labour force who are well versed and experienced to execute such work without any damage to the adjoined buildings /installation ..
4. No person shall be allowed to participate in the auction unless he deposits the required Earnest Money in shape of CDR.
5. The bids should be quoted in open in presence of all the bidders.
6. No telephonic/telegraphic/postal bid shall be entertained /accepted.
7. The successful bidder shall have to deposit the balance amount of sale value Within seven days and shall have to execute an agreement with the Divisional Manager (Extraction), J&K, SFC Jammu. The terms and conditions of this auction notice shall be the part of the Agreement .
8. The security deposit of the successful bidder shall be released after the successful completion of work within the prescribed time schedule.
9. The quantity of the standing trees as indicated in the Annexure are duly marked and numbered.



10. The successful bidder is required to fell the auctioned trees and remove converted material within 30 days from the date of communication of the sanction, Extension of time period for whatsoever reasons shall not be granted. However, under special circumstances, the General Manager (west), J&K SFC may consider the grant of extension in the time period. Any stocks, left at site after the end of the working/extended period, shall be treated as the property of the State Forest Corporation and disposed off accordingly, for which no compensation/Claim shall be entertained/accepted
 11. The successful bidder is required to remove the purchased stocks in a way as not to create inconvenience/obstruction to the traffic or electric and communication lines and in case of otherwise a suitable penalty shall be imposed for such inconvenience caused.
 12. The successful bidder is required to immediately remove the purchased stocks from the site and shall not be kept stacked on the road which can create inconvenience to traffic.
 13. The successful bidder shall have to obtain Form-25 from the Forest Department (Territorial Wing), as required under L.T.Rules and it shall be his responsibility.
 14. Once the offer of the highest bidder is accepted and the acceptance is Communicated in shape of sanction, it shall assume the character of final deal of the contract and it will be obligatory on the part of the successful bidder to fulfill the contractual obligations.
 15. The State Forest Corporation shall not be responsible for any damage due to detention/haulage of the trucks for whatsoever reasons or for violation of L.T.Rules.
 16. The successful bidder shall have to use the standard tools and equipments, required for extraction works at his own cost and without causing damage to Other infrastructure, e.g. cable lines, electric poles, telephone lines Government and Public property.
 17. The entire sales, covered under this Notice are subject to levy on VAT, As such, bids quoted should be excluding VAT and other taxes liable under rules.
 18. Only PAN Card Holders will participate in the auction process.
 19. The J&K State Forest Corporation reserves the right to accept or reject any bid without assigning any reasons or notice.
 20. Any other information that may be required by the bidder can be had from the office of the General Manager (West), J&K State Forest corporation Jammu on any working day during the office hours.
 21. Any other condition(s), if found necessary, the same shall be announced separately before opening of the bids.
 22. In case of any dispute between the State Forest Corporation and the purchaser/successful bidder in respect of any sale covered under this Auction Notice, the decision of the Managing Director, J&K State Forest Corporation shall be final and binding on both the parties.




