Whereas, the Corporation conducted its Departmental Promotion Committee meeting on 1st & 2nd August, 2008;

Whereas, in the said meeting the promotion of Field Assistants (now re-designated as Field Supervisors) to the level of Supervisor Grade-II (now re-designated as Block Managers) were regulated under Reservation Rules notified vide SRO-294 of 2005 started from Roster Point No. 10 upto Roster Point No. 28 and no Roster Point was reserved for Schedule Caste candidate in between Roster Point 10 to 28;

Now, in view of the decision of the Departmental Promotion Committee held on 28th July and 4th August, 2012, the following orders are hereby issued:

1. Shri Nath Ram Baghat(Schedule Caste), the then Field Assistant standing at S.No. 14 of the seniority list of 2008 and promoted as Supervisor-II vide SFC Order No. 423 of 2010 dated 29.06.2010 in pursuance of DPC meeting held on 27.03.2010, shall be treated to have been promoted as Supervisor-II under **Schedule Caste category** at Roster Point No. 15 w.e.f 01.08.2008.
