"e" TENDER NOTICE

For and on behalf of J&K State Forest Corporation, e-tenders are invited from registered timber traders for purchasing of imported timber lying at Leh/Kargil, Distt. as per list' given in the **Annexure "A & A1"** of the e-Tender Notice on the following terms and conditions:-

1. Interested traders are requested to quote rates in cft/lot wise in accordance with Annexure attached with the Tender Notice.
2. The timber will be sold "**As it is where it is basis**".
3. The trader should upload the rates on JK Tenders site JKsfc and personally deliver in a sealed envelop along with CDR in the office of Divisional Manager (ITP&SD), J&K State Forest Corporation, Division Leh, **by or before 13th Nov-2015 up to 3:00 PM** and will be opened on **14th Nov-2015 at 1:00 PM**.
4. Each **Tenderer** must accompany **20% deposit** of the bid amount in shape of CDR pledged to D.M.(ITP&SD) SFC Leh from any Branch of J&K Bank.
5. The deposit is to be retained in case of **1st and 2nd highest tenders** and will be refunded to rest of the tenderers. In case of **1st highest tenderer**, the same will be treated as security money and in case of **2nd tenderer** the deposit will be released, when release order is issued to highest the tenderer.
6. Tenders **without CDR** will not be entertained.
7. The **incomplete /over written and conditional tenders** will not be entertained.
8. The **rates offered** should be **inclusive of all taxes**.
9. The **successful tenderer** will have to abide by all the **Rules and Regulations of State Forest Corporation**.

10. The tender opening authority reserves the right to accept or reject any tender without any reasons.
11. The successful tenderer shall be bound to lift the timber within **(Ten) 10 days** from the date of issuance of release order and thereafter the Corporation shall not be responsible for the watch and ward of the timber.
12. In case of any dispute the Managing Director J&K SFC will be the Arbitrator and his decision will be final and binding upon both the parties.
13. Interested parties can pay visit during working hours to Leh and Kargil Disstts, where the imported timber is displayed for sale as per annexure.
14. In case the successful tenderer fails to lift the timber within the prescribed period, the **security deposit of 20%** shall be **forfeited towards SFC.**


