Subject: *Representation of Shri Bansilal Bhagat, Block Manager and others.*

Whereas, the representation of Shri Bansilal Bhagat, (SC) and joint representation of S/Shri Showkat Iqbal Qazi, Azad Singh, Dharam Singh, Ashok Kumar Bhardwaj, Kishore Kumar Shan and Irfan Ahmad Fareedi Block Managers have been received in which they have requested for restoration of their seniority over and above S/Shri Bhag Singh Bhagat and Ram Diyal, Block Managers as both the Block Managers were junior to them in previous class post;

Whereas, Shri Bansilal Bhagat (SC) was initially appointed as Field Assistant on 21.09.1983 subsequently promoted as Supervisor-G-II on 13.11.1997 and figuring at S.No. 143 in the then seniority list of Supervisor-G-II of Jammu region.

Whereas, In the year 2010 some of Field Assistants who belonged to Scheduled Caste category approached to Schedule Caste Forum and even they have sought information under RTI Act. The Forum has also lodged complaint before the J&K State Information Commission in turn the J&K SFC has furnished status report in the matter. The Commission was informed that the issues raised by the Forum have been taken cognizance and the same will be placed before the Promotion Committee in its next meeting.

Whereas, again their cases were placed before the DPC in its meeting held on 28th July and 4th August, 2012 and the DPC decided as under:

- i) Shri Nath Ram Bhagat (SC) the then Field Assistant standing at S.No.14 of the seniority list of 2008 and promoted as Supervisor-II vide SFC Order No.423 of 2010 dated 29.06.2010 in pursuance of DPC meeting held on 27.03.2010 may be given effect from 01.08.2008 at Roster Point No.15.
- ii) Shri Bagh Singh Bhagat (SC), the then Field Assistant standing at S.No.161 of the seniority list of 2008 and promoted as Supervisor-II vide SFC order No.119 of 2011 dated 03.03.2011 (effective from 25.05.2010) against Schedule caste category at S.No.39 in pursuance of DPC meeting held on 27.03.2010 may be given effect from 01.08.2008 at Roster Point No.27.
- iii) Pursuant to above, the roster point at No.39 may be filled up by next senior most available Schedule Caste candidate (Field Supervisor) namely Shri Ram Diyal standing at S.No.142 w.e.f 25.05.2010".

Whereas, on 27.07.2010 the post of Supervisor-G-II was merged with Supervisor G-I and re-designated them as Block Managers vide SFC order No. 503 of 2010 dated 27.07.2010;

Whereas, due to over sight their seniority were fixed in the list of Block Managers instead of Supervisor G-II and due to over sight Shri Bhag Singh Bhagat was figuring at S.No. 51 and Shri Ram Diyal at S.No. 61 and Shri Nath Ram Bhagat did not figure as be superannuate .

Whereas, the seniority position of the following officials for re-fixing in the then seniority list of Supervisor G-II is as under;

Whereas, after inserting their name in the seniority list of Supervisor-G-II, the seniority position of these officials in the seniority list of Block Manager of Jammu region which is reproduced as under;

1. Shri Bhag Singh Bhagat (SC) at S.No. 165 below Shri Mohammad Ashraf Chowhan and above Shri Amrit Singh Balai.
2. Shri Ram Diyal (SC) at S.No.187 below Shri Mohammad Ayoub Malik and above Shri Mohammad Ahsan.

ii. The Block Managers of Jammu region are hereby directed to furnish their objections if any, with regard to re-fixed seniority position of above named officials within a period of 15(fifteen) days from the date of issuance of this order.
