Representation of Shri Mohammad Ashraf Dar, Block Manager for shifting of seniority from Jammu region to Kashmir region and fixation of the same in the seniority list of Block Managers of Kashmir region- objections thereof.

Whereas, Shri Mohammad Ashraf Dar, Block Manager presently posted in SFC Fair Price Division Srinagar has repeatedly requesting for shifting of his seniority from Jammu region and fixation of the same in the seniority list of Block Managers of Kashmir region on the plea that he was initially appointed as Lumber Guard vide SFC order No. 516 of 1982 in Kashmir region and was posted to Sales Depot Doabgah of Sales North Division Srinagar;

Whereas, the said official has stated that his seniority has arbitrarily been fixed by the Management in Jammu region without his consent;

Whereas, on examination of the available record it has been observed that Shri Mohammad Ashraf Dar, Block Manager was initially appointed as Lumber Guard vide SFC Order No. 516 of 1982 and was posted in Doabgah Sales Depot of Sales North Srinagar and subsequently in the year 1985 he was transferred to Jammu where he remained posted in different Divisions of Jammu region for more than 18 years and his seniority was also maintained at Jammu region;

Whereas, Shri Mohammad Ashraf Dar, Block Manager was promoted as Supervisor-G-II "Under Graduate Quota" vide SFC Order No.150 of 1988 dated 06.05.1988 and till date he remained in the seniority list of Jammu region instead of Kashmir region;

Whereas, it was felt that the claim of the applicant is genuine and need s to be redressed by shifting of his seniority from Jammu region and its fixation in the seniority list of Block managers of Kashmir region at appropriate place on the basis of his initial appointment as well as his promotion as Supervisor-G-II;

Whereas, in case the seniority of Shri Mohammad Ashraf Dar, Block Manager is shifted to Kashmir he will figure at S.No. 31 (a) in the seniority list of Block Managers of


Kashmir region i.e. below Shri Ali Mohammad Bajard figuring at S.No.31 and above Shri P.L. Kachro figuring at S.No.32.

Whereas, in this regard a notice was issued vide this office NO. 903-34/Bix/SFC dated 14.01.2015, inviting objections from Block Managers of Kashmir region figuring from S.No.32 and on wards and were directed to furnish objections, if any, within a period of 10 days time from the date of issuance of this notice;

Whereas, after expiry of more than one month, no objections from any Block Manager from Kashmir region has been received so far by this office;

Now, therefore, it is hereby ordered that the seniority of Shri Mohammad Ashraf Dar, Block Manager is hereby shifted from Jammu region and fix his seniority in the seniority list of Block Managers of Kashmir region at S. No. 31 (a) i.e. below Shri Ali Mohammad Bajard figuring at S.No.31 and above Shri P.L. Kachroo figuring at S. No.32 .
