This is issued subject to the following terms and conditions:-

1. The Divisional Manager (FPSD) Jammu shall ensure that cost of timber alongwith taxes as warranted under rules is received in the shape of Demand Draft in full.
2. The Divisional Manager (FPSD) SFC Jammu shall ensure that the consumer lifts the timber strictly as per the release order against allotment given above.
3. The Divisional Manager (FPSD), SFC shall issue individual case wise Release Order/Bill against the full and final payments and thereafter ensure lifting by consumer.
4. The timber sanctioned is to be released in favour of actual consumers only, and under some un-avoidable circumstances the same can be released in favour of duly authorised representative of the actual consumer.
5. The Divisional Manager (FPSD), SFC shall ensure that the original Ration Card/Building permission is duly stamped at the time of release of the stocks.
6. In addition to the above, the conditions as laid down in the individual sanctions to be issued subsequently by the Divisional Manager (FPSD), SFC Jammu are also to be observed in letter and spirit.
7. The Divisional Manager (FPSD) SFC Division shall ensure that the consumers be informed on phone/SMS accordingly as per the availability of timber in Depot.
8. The sanction shall remain valid upto 31.03.2016, there after the timber shall be issued on the prevailing rates of that particular year as would be decided by the steering committee of the J&K State Forest Corporation.
