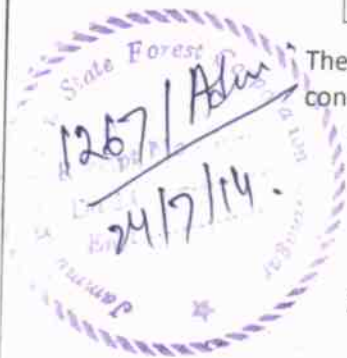

The auction through open bid will be conducted in accordance with the following terms and conditions:



The stuff to be auctioned are available in PC depot dully numbered list of which can be had from office of Divisional Manager Sales North on demand.

The participants shall have to produce CDR amounting to Rs. 75,000/= in respect of PC Depot-I and 60,000/= in respect of PC Depot-II respectively pledged to Divisional Manager Sales North which shall be treated as Earnest Money. The successful highest bidder shall have to deposit 10% of the bid amount in cash on spot.
3. The successful bidder shall have to deposit balance amount of sale value within 15 days in the shape of CDR/bank draft payable at Srinagar Branches of the concerned Banks. The CDR/Bank Drafts must be deposited within <sup>the</sup> concerned Divisional Manager Sales North before the expiry of scheduled period in all cases.
4. The successful bidder will be required to lift the purchased stocks within 30 days from the date of auction of stocks failing which the amount shall be forfeited and the stuff left shall be re-auctioned without any fresh notice to the successful bidder.

15. In any sought of "proof" of "ring" formation amongst the bidders is suspected at any time, the Divisional Manager Sales North shall be at liberty to cancel the same even after the conclusion of auction.
