TERMS AND CONDITIONS:

1. Stocks sold under these auctions are to cater the local needs only.
2. The rate offered shall be including taxes.
3. While as earnest money @ 25% and 10% of the total value of timber for Reduction & Normal Sale respectively shall be received from successful bidders/ purchasers on spot at the fall of hammer. The Earnest Money shall be received in the form of Demand Draft or Cheque (JK Bank only). In no case the Earnest Money Deposit in the form of cash shall be accepted.
4. The Corporation shall offer no rebate on Reduction Sale. However, in case of Normal Sale rebate as per provision shall be allowed.
5. Full payment against the stocks purchased shall be made by the bidder/purchaser through CDR/Bank Draft payable at Srinagar Branches of the concerned banks. The CDR/Bank Draft must be deposited with the concerned DM Sales of FDC before expiry of the schedule period.
6. The terms and conditions and rules governing the timber trade and its transportation issued by the Forest Department from time to time shall be binding on all the intending bidders/purchasers.
7. The intending bidders registered with the Forest Department shall offer their bids in their name and style.
8. All the participants shall bring their self-declaration on prescribed format regarding ITR for the previous two years to get benefits of TCS at Normal Rates. They are also required to submit the Photostat copies of their Pan Cards.
