Shri Shah has initially been appointed as Lumber Guard on 17.06.1980 , promoted as Assistant Supervisor on 15.06.1983 and as Supervisor Grade –I on 11.12.1993

Whereas, Shri Mohammad Sharief Shah is off and on representing for shifting of his seniority from Jammu region and fixation of the same in the seniority list of Block Managers of Kashmir below such Block Managers who are drawing the pay scale of 9300-34800 with Grade Pay of ₹ 2800;

Whereas, Shri Shah has also filed a writ petition in the Hon'ble court at Srinagar in SWP No. 1174/2010;

Whereas, the Hon'ble Court vide its order dated 09.11.2012 disposed the above writ petition with the following directions:

“Petition, at request, is taken up for final disposal.

The writ petition is disposed of with the direction to respondents to accord consideration to the petitioner's claim for promotion/fixation of seniority having regard to the averments made in the petition and in light of the annexures appended thereto and last but not least in view of the rules governing the matter.

Respondents shall do well to decide the matter within eight weeks from the date of copy of the order is provided to them. Petitioner, at his option, may hand over the copy of the petition and copies of all its annexures to respondents in order to facilitate the early disposal of the matter”.
